

2025 – 2026 School Choice Vouchers

Overview

We are excited to announce Heartland's application to become a qualified school for the 2025-2026 School Choice Voucher Program has been approved!

The student application process is now open and will close on August 20th. Once the application period is closed no additional applications will be accepted.

Eligibility

To be eligible to participate in the voucher program the student must meet the following criteria:

- Have a legal settlement in Indiana
- Be between the ages of 5 and 22 by October 1, 2025
- Be enrolled to Heartland for at least 50% of the school day
- A member of a household with an annual income of not more than 400% of the amount to qualify for the Federal Reduced Price Lunch Program (chart below)

Tuition

As we have been approved for the 2025-2026 voucher program our goal is to reduce tuition cost to families. With the average voucher award amount being \$6,500 we have set our tuition for the upcoming year at \$8,500 per student resulting in an estimated 50% reduction in your out-of-pocket expenses. Voucher award amounts are determined based upon the school district you reside in so voucher amounts and tuition cost will vary from family to family. Below is a list of estimated voucher award amounts by school district. If your school district is not included in the list provided, please let me know and I'll be happy to provide that figure.

To apply for the School Choice Voucher, you will need to complete a Parent Signature Form as well as provide the first page of your 2024 income tax return showing your adjusted gross income (AGI). Applications and income documentation will need to be submitted to Amy Coffin in the finance office. Face to face meetings can be arranged if desired.
